**Form of Bond of Indemnity for Drawing the Amount due for Gratuity / Death Gratuity /
Life Time Arrear Pension / Arrear Salary / Provident Fund Due etc.**

KNOW ALL MEN by these presents that I (a) Sri/Smt./Md.
Wife/Son/Daughter of resident of Village Post
Office, Police Station, District
the widow / son / daughter of (b) Late and I/We (c)

sureties on his/her behalf are held and firmly bound to the Governor of the State of West Bengal in the sum of
Rs. (Double the Amount) only to be paid to them or his/her successors or assigns for
which payment to be well and truly made each of his severally binds himself and his heirs, executors
administrators and assigns and every two and all of us jointly bind ourselves and our representatives heirs,
executors administrators and assigns firmly by these presents.

AS witness our hands thisday of, whereas (b) Late
..... who was at the time of his death in the employment / of the School of
District School Board, Murshidabad under the control of the District Inspector of Schools, Primary Education,
Murshidabad was but was a member of D.C.R.B. Scheme, 1981 of the Employees of Non-Govt. Recognised
Institution, on account of that Scheme of Rs. As payable by the authority is payable on

AND WHEREAS the Government desires to pay the said sum to the claimants but under Government
Rules and Orders it is necessary that the claimants should first execute a bond with one surety / two sureties to
indemnity the Government against all claims to the amount so due as aforesaid to the said.
